Executive Summary

The National Student Financial Aid Scheme (NSFAS) is a statutory body providing financial aid to eligible students who wish to study at public universities and Technical Vocational Education and Training (TVET) colleges. NSFAS is mandated to manage and distribute funds in accordance with the provisions of the NSFAS Act (Act 56 of 1999).

Fraud and Corruption

All providers are to take note of the implications of contravening the Prevention and Combating of Corrupt Activities Act, Act No 12 of 2004 and any other Act applicable.

Clarifications / Additional information / Rights / Appeals

Clarification

Any clarification required by a bidder regarding the meaning or interpretation of the TOR, or any other aspect concerning the bid, are to be requested in writing by email from scm@nsfas.org.za. The bid number should be mentioned in all correspondence. Telephonic requests for clarification will not be accepted. If appropriate, the clarifying information will be made available to all bidders by e-mail only.

Tenders can be delivered and deposited into the tender box between 08:30 and 17:00, Mondays to Fridays and, prior to the closing date, and between 08:30 and 11:00 on the closing date.

No faxed or e-mailed quotations will be accepted. All tenders must be submitted on the official forms (not to be re typed).

Only bids that are submitted as one (1) original and one (1) copy will be accepted as valid and responsive.

The original and copies will be distributed to the bid evaluation committee and must contain the same information; and must all be neatly marked and professionally presented. All bid documents should be referenced.

Respondents should ensure that tender documents are delivered to NSFAS before the closing date and time to the correct physical address. If the tender document is late, it will not be accepted and will be disregarded.

Any tender submitted shall remain valid, irrevocable and open for written acceptance by NSFAS for a period of 120 (one hundred and twenty) days. A tender submitted shall further be deemed to remain valid after the expiry of the above mentioned 120-day period until formal acceptance by NSFAS, unless NSFAS is notified in writing by the tenderer of anything to the contrary (including any further conditions the tender may introduce). Any further conditions that the tenderer may introduce will be considered at the sole discretion of NSFAS.

LATE BIDS

Bids received late will not be considered for evaluation purposes. A bid will be considered late if it arrived even one second after 11:00 am or any time thereafter. The tender (bid) box shall be locked at exactly 11:00 am and bids arriving late will not be considered under any circumstances. Bidders are therefore strongly advised to ensure that bids be dispatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

Bids sent to the NSFAS via courier shall be deemed to be received at the date and time of arrival at the NSFAS premises (tender/bid box or reception). CONTACT CENTRE SOLUTION

The National Student Financial Aid Scheme (NSFAS) is a public entity accountable to the Department of Higher Education and Training (DHET). It provides financial assistance to eligible students at public universities and at Technical, Vocational, Education and Training (“TVET”) colleges throughout South Africa.

The Contact Centre is a vital component of NSFAS’s new student-centric operating model and is the primary source of contact for students. In the new model, the student is at the heart of our operations and it is our goal to deliver the best possible experience across every touch point. The vision of the Contact Centre is to become a centre of excellence by being accessible, transparent and reliable to all stakeholders.

The Contact Centre aims to deliver value to the rest of the organization and enhance the student experience bringing deeper client insight by providing agents with the technology such as hosted or cloud-based solutions, and skills to deliver consistent service. Within the Contact Centre industry, new technologies are emerging that help reduce agent wait time, route calls to the appropriate skilled agent, enhance forecasting and scheduling, improve agent productivity, and supporting multi-channel engagements. NSFAS would like to take advantage of these technologies and be able to rapidly scale (in and out) the number of agents and the services they support.

NSFAS currently utilises a Hosted Call Centre solution provided by an external service provider, currently configured for 90 Agents. NSFAS wishes to explore the options to scale the number of lines, as well as the number of agents, to ultimately improve the service levels and enable the Call Centre to service more callers.

NSFAS has a toll-free number of which links to a number provided by the external service provider. The toll-free number is operated by Telkom and managed directly by NSFAS. This toll-free service enables the caller to contact NSFAS at no cost to them, but for the full call cost to be collected from NSFAS by Telkom. The external service provider collects calls from this number at a Point of Interconnect and sends these calls to the dedicated Hosted Call Centre solution based in Teraco which can accommodate up to 160 concurrent calls.

Callers are initially presented by the Hosted Call Centre IVR where they are provided with a Welcome Message and to dial the option which best describes their reason for calling. Once the caller has selected an option, the call is transferred to the appropriate queue and associated agents.

The Service providers are requested to provide a system that will be able to do the following:

- *Take Ownership of the toll-free number from Telkom & ensure that caller doesn't pay for the call.*
- *Supply a hosted Contact Centre Solution or Contact Centre as a Service Solution (CCaaS).*
 - *Accessible from any location with Internet connection, including management reports.*
- *Design/map customisation of the system and related workflows within a rules/exception-based environment aligned to proposals of best practice.*
 - *To include outbound dialler with ability for user to schedule call-back request, based on specific business rules.*
- *Implementation, deployment and roll-out of the software / system and all of its components*
- *Migration from current systems and services into the integrated solution(s)*
- *Provide business support services including On-going technical and user support for the duration of the contract.*
- *Maintenance agreement of the systems over the duration of the contract period.*
- *Solution should be scalable up/down, and only pay for actual usage.*
- *Provide additional resources (Contact Centre Agents, seating and technology), as and when required to allow NSFAS contact centre to scale out when needed during peak season or for business continuity purposes.*
- *integrate a hosted Contact Centre Solution with Customer Relations Management (CRM)*

- 6.13. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
- 6.14. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- 6.15. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years

in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
